## WEEKLY UPDATE

3/3/2021

Dear Residents and Families/Representatives,

Please accept this letter as our weekly update regarding the status of COVID-19 in our facility. Since the onset of this virus, we have had 124 residents and 36 staff members test positive for COVID-19. We are continuing to test our employees twice a week on Mondays and Thursdays and our residents weekly. We are following the guidelines for COVID-19 positive results. Our county positivity rate is at 11.1%

As always, we are working hard to keep everyone in our community safe and we will continue to practice the enhanced safety precautions that are known to prevent the spread of COVID-19, such as only essential personnel are allowed inside the facility and we screen them for signs and symptoms of illness prior to entering. Our residents are continually monitored and staff is using PPE as recommended by the CDC. Staff is frequently reminded and encouraged to practice social distancing and to use hand sanitizer and frequently wash their hands when they are in the facility and out in the community. We ask them not to report to work if they have symptoms of illness.

### Weekly Update 3/24/2021

Dear Residents and Families/Representatives,

Please accept this letter as our weekly update regarding the status of COVID-19 in our facility. We are happy to report that, as of today, we have no confirmed cases of COVID-19 in our facility. Since the onset of this virus, we have had a total of 125 residents and 37 staff members test positive for COVID-19. We continue to test residents weekly and staff twice a week.

We will begin allowing outdoor visitation and restricted indoor visitation on Monday 3-29-2021. We will be following Center for Medicare Services (CMS) Guidelines for indoor visitations. The visiting hours are as follows:

Monday – Friday 930am – 1130pm and 1pm – 4pm  
Saturday and Sunday – 10am – 12pm and 1pm – 3pm

Please call 864-472-9055 and schedule a time to visit during these times.

General rules for Visitation:

- All visitors will complete a visitation screen prior to visiting
- Mask must be worn during entire visit (NO CLOTH MASKS allowed)
- Maintain a distance of 6ft during visits
- Proper hand hygiene will be performed before visitation begins
- 2 Visitors will be allowed to visit their loved one at one time
- Visits will be 30 minutes
